Pursuant to the decision of the High Power Committee taken in its meeting held on dtd. 11-01-2023 as communicated vide Govt. in the **Department of School & Mass Education Letter No. 3094 / SME., Dt. 08-02-2023** and as per the guidelines issued by Government in the Department of School & Mass Education, Odisha, Bhubaneswar vide Resolution No. 30720/SME dtd.23.09.96 read with G.O No. 29519/SME dtd. 26.9.1998 **No Objection Certificate (NOC)** is hereby granted in favour of **Prabhujee English Medium School, Rajbati, Rathasahi, Rairakhol, Sambalpur** for a period of **One Year i.e. up to 31-03-2024** to upgrade / run Self Financed High School with class- IX & X which is to be affiliated to **CBSE** subject to following terms and conditions. The extension of NOC beyond **One Year** will be considered after ensuring fulfillment of the terms and conditions.

1. The No Objection Certificate now issued shall be subject to the terms & conditions as prescribed in G.O No. 30720/SME dtd.23.09.96 and No. 29519/SME dtd. 26.09.1998 read with G.O No. 10011/SME dtd.11.06.2004. Any relaxation extended this year shall be fulfilled within one year.
2. The school shall be opened to inspection by the Officers of S & ME Deptt. as and when required.
3. No Financial Assistance or any kind of Grant-in-Aid ( either recurring or non-recurring ) will be claimed by the institution from the Government at any point of time .
4. The High Power Committee shall be competent to review the NOC now granted to the institution concerned and shall be competent to withdraw the same on violation of terms and conditions laid down in Govt. Acts / Rules / Executive Instructions ..
5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Odisha Education Act-1969 as amended from time to time.
6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.
7. The land on which the school stands is recorded in the name of the Trust / Society / Agency which manages the School. It will be the responsibility of the School Authority to record the required land (1.00 Ac in Urban / 1.50 Ac. in Rural ) in the name of the school and submit copy of the RoR to this Directorate within one year for continuance of NOC.
